1. Assumption of Risk

I, the undersigned parent or legal guardian of the above-named participant, understand and acknowledge that participation in educational programming at the Regina Humane Society ("RHS") involves interaction with animals and participation in related activities which may carry inherent risks, including but not limited to animal bites or scratches, allergic reactions, physical injury, and emotional distress. I acknowledge that all reasonable precautions will be taken by RHS to ensure the safety of participants, but I voluntarily assume all risks associated with my child's participation.

2. Waiver and Release of Liability

In consideration of my child's participation in RHS summer programming, I hereby release, waive, and discharge the Regina Humane Society, its directors, officers, employees, agents, volunteers, and sponsors (collectively, the "Released Parties") from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, injury, or illness that may be sustained by my child or myself during or in connection with participation in RHS programs, whether caused by negligence or otherwise, to the fullest extent permitted by the laws of the Province of Saskatchewan and Canada.

3. Medical Consent

I authorize RHS staff or volunteers to provide first aid or seek emergency medical treatment on behalf of my child if I cannot be reached in the event of an emergency. I accept responsibility for all costs associated with such medical care.

5. Code of Conduct

I understand that the Regina Humane Society expects all youth participants to behave respectfully toward staff, volunteers, animals, and other participants. RHS reserves the right to dismiss a child from the program if they engage in behaviour that is disruptive, unsafe, or inappropriate. No refund will be issued in such cases.

6. General Provisions

This waiver shall be governed by and interpreted in accordance with the laws of the Province of Saskatchewan and the laws of Canada applicable therein. If any provision of this waiver is held to be invalid, the remainder shall remain in full force and effect. This waiver shall be binding upon my heirs, executors, administrators, and assigns.
